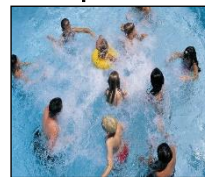

## **Property Managers Corner** **Spring Yard Work Plus**

**LANDSCAPING** - It's that time again! Bushes need to be trimmed, weeds need to be removed, and grass needs to be mowed and edged.

**MAILBOX** - Make sure your mailbox is in good condition and is the approved post style found on the website. Sharp edges are not allowed and should not obstruct the sidewalk with proper address number marking.

**CHANGES or REPAIRS** – You are required to submit a request to the Architectural Control Committee (ACC) before making any Painting, landscape, structural, or roofing changes to the outside of your home. The covenants and ACC form are found on the website you may obtain an ACC form and email requests to [propertymanager@glenatgrandview.com](mailto:propertymanager@glenatgrandview.com)

**YARDS** - Please make sure your trash and recycling containers are out of view from the street and your neighbors. Be sure to store your lawn equipment, sporting goods, toys, grills, etc., out of view.

**PETS** – Please be courteous to your neighbors and their lawn by picking up your pet's waste. It is your doodee.

### **COVENANT VIOLATIONS – PLEASE READ**

**CMA** conducts monthly property inspections and mails covenant violation notices to members. Homeowners are required to take corrective action and communicate they have complied back to the property manager. The HOA reviews delinquent violations regularly and will take action against delinquent properties with an HOA-supplied vendor. Vendor costs will be charged back to the property owner. **The covenants give the HOA legal right of way onto your property to correct covenant violations as you agreed to when you purchased your home in Grandview. You may also face additional costs, legal fees, and privileges loss as allowed in a court of law.** Thank you for your cooperation and for keeping Grandview beautiful!
